### 3.1.1 Rezoning 495 Riverside Drive

For the purpose of the Zoning By-Law, the zoning remains "Institutional", but in addition to the uses permitted in the "Institutional (IN) Zone", it will be permitted to develop a Student Residence in the existing main building subject to terms and conditions prescribed by Council.
