6. PUBLIC AND ADMINISTRATIVE PRESENTATIONS

6.1 2024 Bathurst Harvest Festival Corvette Event by Evelyne Valotaire and Marc Willett

Marc Willett and Evelyne Valotaire are members of the Moncton, Nova Scotia and Saint John Corvette Clubs. They participate in municipal festivals that have antique car shows with a corvette display element. Two years ago, they attended the Bathurst Harvest Festival car show with three Corvettes. The following year, they decided to incorporate a corvette section into the festival's car show, as other Maritime towns do. Their small group promoted it throughout the year, resulting in one of the largest gatherings of corvette enthusiasts in the Maritimes.

On Friday evening, a get-together was held at 13 Barrels for around 100 participants, catered by Pizza Delight, which was a great success for showcasing the waterfront. On Saturday, 72 corvettes registered for the car show and over 100 people discovered Bathurst, shopped downtown, and ate at local restaurants. After the car show, they paraded from downtown to Petit-Rocher and back to Bathurst. Their plan to attract people to Bathurst turned out to be bigger and better than they had imagined. As it turns out, Bathurst has set a new standard for Maritime Corvette Club events. This resulted in revenue to the local bars and restaurants, and over 40 hotel rooms were booked for two nights. After all expenses paid, the club was able to donate \$925 to the Bathurst homeless shelter.

Many of the club members had never been to the region, but they will be coming back and promoting it. At the annual meeting of the Nova Scotia Corvette Club in December, the president announced that the Bathurst event in September is the must-attend event of 2024. They expect to welcome groups not only from the Maritimes, but from Quebec and Bar Harbor, Maine. To date, they are expecting between 70 and 80 cars. The Best Western is already fully booked, and further reservations are being made at the Quality Inn.

This year's meet-and-greet will take place on Friday, September 20. The group would like to reserve 13 Barrels for a private event from 6 pm to 9:30 pm. The car show will take place on Saturday, followed by dinner at the marina, and the group would like to offer bus service in the evening.

The group is asking for \$3,550 to cover the cost of the bus and 13 Barrels for a private event. Other costs will be covered by sponsors, registration fees and individual participants. They would also like the Tourist Office to donate bags containing brochures, pins, pens and other gifts.

Council members stated that the purpose of the Tourism Levy Fund is to encourage these types of tourism events. The request will be added to a future council meeting agenda for discussion.
