# 6.1 2024 Annual Bathurst Bass Jam by Derick Devereau

Mr. Derick Devereau, founder of the Annual Bathurst Bass Jam Festival, gave an overview of the event that started in 2017. Bass Jam is a car audio competition held here in Bathurst; it's the largest event of its kind in the Atlantic Provinces. Mr. Devereau hopes to continue to have the support of the City of Bathurst and the Hospitality Days Committee. The event will be held on July 20 and 21, 2024. He would like to hold the event in the employee parking lot of the federal building or the lot next to the 13 Barels. Both are the ideal size to host the event safely and close enough to capture the attention of spectators who are nearby enjoying other events within the area. Mr. Devereau revealed last year's award and a prototype for the 2024 award. The cost for the awards is \$500, he is requesting a \$250 donation to help cover half the cost; he received an anonymous donation for the other half.

Council suggested that Mr. Devereau meet with the Hospitality Days Committee to discuss the possibility of holding the event in the proposed parking lots, and the grant committee will review his donation request.

#### 8. MUNICIPAL BY-LAWS

### 8.1 Receipt of the Planning Advisory Committee Recommendations

# 8.1.1 For Property Located at 495 Riverside Drive

Director of Municipal Planning, Marc Bouffard, presented the Planning Advisory Committee (PAC) recommendations for the property located at 495 Riverside Drive.

The proposed conditions are as follows:

- It will be permitted to develop a student residence in the existing main building on the parcel in addition to the other uses permitted in the Institutional (IN) Zone.
- "Student residence" means a residence with single or double rooms intended solely for students
  enrolled in a post-secondary institution on the CCNB Campus. The residence must also include
  shared sanitary, culinary and social facilities.
- The existing accessory building must remain accessory to the main building.
- Student residence:
  - o Shall contain a maximum of 34 residents in 32 bedrooms.
  - Shall have a proctor to ensure discipline and report to the owner.
    - A student resident may occupy this function.
  - Applicants shall provide a written document describing the means that will be taken to ensure and guarantee that the residence will be occupied solely by students enrolled in the postsecondary institution on the CCNB Campus.
  - The only residential uses permitted on the parcel are:
    - a student residence,
    - a nursing home, a senior citizen home or a group home (already permitted in the Institutional Zone).
  - o For greater certainty, rooming houses, boarding houses and tourist homes are not permitted uses on the parcel.
  - o The parcel shall be developed in accordance with the site plan attached to the by-law.
  - o If the parcel is developed for a student residence, Planning Advisory Committee's approval is required to change:
    - the perimeter of the landscaped area,
    - the existing surface parking area,
    - the existing driveways,

- the footprints of the 2 existing buildings.
- Any development that, in the opinion of the Planning Department, varies the site plan shall be approved by the Planning Advisory Committee.
- The student residence must be developed within 24 months, otherwise the parcel reverts to its current zoning.
- Shall comply with the National Building Code, and other regulations including those applicable to barrier-free designs.
- o The owner shall obtain all required authorizations from the Department of Environment and Local Government:
  - A watercourse and wetland alteration permit is required within 30 meters of the top of banks.
- All other zoning provisions applicable to the "Institutional Zone" continue to apply to any use, building or structure on the parcel.
- The parcel and any building or structure on it shall not be developed or used except in accordance with the conditional rezoning agreement.

# 8.2 Hearing of Objections or Support Regarding Proposed Municipal Plan Amendments

# 8.2.1 For Property Located at 495 Riverside Drive

For the property located at 495 Riverside Drive, the public notice required under Section 111 of the *Community Planning Act* concerning the zoning by-law amendment project was published. Twelve written objections were received and read by the City Clerk.

The mayor invited members of the public to give their opinions regarding the proposed zoning by-law amendment for the property located at 495 Riverside Drive.

Objections were heard from Micael Savoie, Marilyn Gallagher, and William Meahan, residents of Riverside Drive, as well as Craig Melanson of Princess Street.

The concerns brought forward during the objections, either in writing or in person, were as follows:

- Public health and safety for the students and the residents of Bathurst
- The rezoning and amendment go against the municipal plan
- Lack of consultation and transparency
- Discrimination that students can only be those from CCNB
- Crosswalk/sidewalks/parking
- Cleanliness indoor and outdoor
- Traffic at all hours
- Noise disturbances
- Security/Building Supervision or Proctor (student)
- The institution should be responsible to regulate student housing not developers

- Concerned that it will turn into a 'flop house'
- Property value decrease

The developers were given the opportunity to rebuttal. Chris Drysdale read the letter of support that they received from the president of CCNB for the proposed project. The letter stated that the CCNB has experienced exponential growth at its Bathurst campus seeing a 22% increase of its student body population over the last year, representing 683 students for the 2023-2024 college year. They noted that the biggest factor limiting the CCNB growth is a lack of affordable, appropriate, and safe housing for students. The proximity of the project is also of importance as the Bathurst region does not currently have public transportation, and most students do not have a mode of transportation. The letter also stated that over the years, the developer has been a significant partner of the CCNB, housing many of their students; they are the preferred landlord of many of their students. For these reasons, they fully support the project and are anxious to see it move forward.

Mr. Drysdale responded to the questions of security and cleanliness. The building will be locked at all times and students will require a passcode to gain entry. There will be security cameras in all common areas inside and out, and there will be strict rules that the students will have to follow. The students will be responsible for the cleanliness of their respective rooms, and they will hire someone to come in three times a week to maintain and clean the common areas of the building. To strengthen security even more, they will appoint a student resident to notify the owners if there are any concerns. A valid student ID will be mandatory when signing the 10-to-12-month lease agreement. He adds that there is a lack of housing across the province and the project supports and goes along with the municipal plan and the provincial plan to increase housing in the area.

Mr. Mike Doucet stated that there is no zoning for student housing in Bathurst. He added that the proposed project is a structured building that's going to have a lot of amenities for students. Students want a safe living place and that is what the project is offering.
