6.1 Update on Water and Sewer Rate Change by Sonia Gauvin

The City Treasurer gave an update on the water and sewer rate change.

6.2 Flat Rate for Water and Sewage by Terrence Lenihan and Jocelyn Michaud

Speaking for Mr. Michaud, the owner of the Westmount Apartments, Terrence Lenihan appears before Council with respect to the new water and sewage flat rate. They recommend that council retain the water meters in buildings with five, ten or more units to reduce the rate for one-bedroom and bachelor apartments and categorize them as non-residential. They argue that these one-bedroom and bachelor apartments in the city provide affordable housing for students, low income and persons on social assistance and that the tenants are not eligible to receive the 10% discount for lower incomes.

8. MUNICIPAL BY-LAWS

8.1 Receipt of the Planning Advisory Committee Recommendations

8.1.1 Revision of Zoning Provisions Relating to Parking and Multi-Family Dwellings

Members of Council intend to consider the following amendments to By-law 2008-01 entitled "The City of Bathurst Zoning By-law" as follows:

Amend certain provisions of the Zoning By-law concerning:

- a. The number of parking spaces required for residential buildings and
- b. The height of residential buildings in the Downtown Commercial Zone (Zone CCV).

The Planning Advisory Committee has sent a favourable recommendation to Council concerning the proposed amendments to the zoning by-law as submitted.

8.2 Hearing of Objections or Support Regarding Proposed Municipal Plan Amendments

8.2.1 Revision of Zoning Provisions Relating to Parking and Multi-Family Dwellings

For the proposed modifications to the zoning by-law, public notice required under Section 111 of the *Community Planning Act* pertaining to the draft amendment of the Zoning By-Law were published. No written objections were received.

The mayor invites members of the public to express their opinions to the proposed Zoning By-Law amendment three times. No objections were received.

8.3.1 First Reading of By-Law 2024-07Z

9. DRAFT RESOLUTIONS

9.1 Amendment to the Municipal Plan and the Zoning By-Law Pursuant to Section 111 of the Community Planning Act

9.1.1 1945 Miramichi Avenue

WHEREAS the City of Bathurst proposes to amend By-Law No. 2006-01 entitled "The City of Bathurst Municipal Plan By-Law" and By-Law 2008-01 entitled "The City of Bathurst Zoning By-Law" to allow the designation and use of the following lands as follows:

Change the land use of a portion of the lands located at 1945, Miramichi Avenue and bearing PID 20035986 and 20538278. For the purpose of the Municipal Plan, the land use is changed from "Commercial" to "Industrial". For the purpose of the zoning by-law, the zoning is changed from "Highway Commercial" to "Light Industrial".

The purpose of this rezoning is to change the use of the former Nissan car dealership to enable a workshop specializing in the manufacture and refurbishment of electrical equipment by two companies already established in Bathurst, namely Black & McDonald and Power Precision.

BE IT RESOLVED THAT

- a. By-laws amending the Municipal Plan and Zoning By-law be drafted for this purpose,
- b. The City Clerk, acting on behalf of the Council, see that the public notice prescribed in section 111 of the *Community Planning Act* is posted on the municipality's website to announce the Council's intention, the day and place for the consideration of objections to the proposed by-laws, and
- c. Consideration of objections to the proposed by-laws take place at 6:30 p.m. on June 3, 2024, in the Council Chambers.
