### 8. MUNICIPAL BY-LAWS

8.1 Adoption of Restrictions and Conditions Pursuant to Section 59 of the Community Planning Act for Property Located at 1945 Miramichi Avenue

WHEREAS Council members approve the agreement between Red Rock Properties, Black & McDonald Limited and the City of Bathurst and that the Mayor and City Clerk be authorized to sign all related documents on behalf of the City; and

WHEREAS the applicant has been authorized by the current owner of land bearing PID 20035986 and 20538278 as shown in Schedule A of By-law No. 2024-06Z, to proceed with the rezoning of the said land (hereinafter named the "parcel(s)"); and

WHEREAS the Municipality has received a request from the applicant to amend the zoning of said parcels to allow the relocation of businesses already operating in the City of Bathurst under the corporate names of Black & McDonald and Power Precision; and

**WHEREAS** the Council intends to adopt By-law No. 2024-06Z to permit this development as a conditional rezoning pursuant to section 59 of the *Community Planning Act*; and

WHEREAS the Council wants to add terms and conditions through a conditional rezoning agreement attached to By-law No. 2024-06Z to ensure, once the rezoning is completed, that the parcel is developed in accordance with the terms and conditions listed in the agreement; and

**WHEREAS** subsection 59(2) of the *Community Planning Act* stipulates that this agreement, once entered into, will only take effect after certified copies of the rezoning by-law and the agreement are filed in the land registration office.

**NOW THEREFORE BE IT RESOLVED** that the following terms and conditions be imposed on the parcel:

- 1. A maximum of 8 stationary containers for the storage of materials and tools used by the company will be permitted. These containers must be placed only in the side yard between the building and the parcel bearing the PID 20848891 (Armour transportation). A maximum of seven 20-foot containers may also be parked in the side yards, to be moved and used as construction box on construction sites.
- 2. With the exception of equipment to be installed in E-Houses stored outside, all other work and activities must be carried out inside the building.
- 3. Building doors must be completely closed when noisy work is being carried out indoors. The provisions contained in By-law No. 2005-14 respecting the prevention of excessive noise within the City of Bathurst continue to apply.
- 4. All provisions of the Zoning By-law continue to apply.
- 5. No exterior lighting shall project or overhang onto neighbouring properties.
- 6. If and when required by the City of Bathurst, the owner shall install and maintain a 6-foot-high fence along residential properties to act as a visual screen.
- 7. The above-mentioned terms and conditions are binding upon the parties, their administrators, officers, heirs, and assigns.

- 8. On the rezoning of the land, the land in the zone and any building or structure on the land shall not be developed or used except in accordance with this conditional rezoning agreement, the terms and conditions imposed, and the time limits prescribed.
- 9. The parties acknowledge having read the contents of this document and declare having signed it.
