# 6.5 Old Bathurst Post Office Preservation Project by John Mann and Brian Hoffman

M. John Mann, president of the Old Bathurst Post Office Preservation Project, and Brian Hoffman presented a progress update on the project including a revised vision for the space.

The city has committed to contributing \$100,000 (\$20,000 a year for 5 years starting in 2023) which has helped to fund the building assessment and the new electrical service. They are requesting an additional grant of \$100,000 and permission to install a temporary sign promoting the Chase the Ace on the OBPO property along Main Street. The funds will be used for the heating system to prevent further interior deterioration and to allow work to continue through winter.
