## 6.1 Collège communautaire du Nouveau-Brunswick (CCNB) by Pierre Zundel

Pierre Zundel, CEO of the Collège communautaire du Nouveau-Brunswick (CCNB), presented the CCNB Bathurst Campus Facilities and Lands Master Plan which will guide development strategies over the next 30 years, addressing CCNB's needs and those of its community and partners. It focuses on training and innovation to drive progress for the institution, region, and province. The plan aims to provide concrete objectives for current and future facilities.

The vision for the campus is to create an innovative, accessible learning hub with sustainable, flexible designs that integrate various groups. Key principles include integrating innovative learning into the campus design, promoting adaptable spaces, fostering innovation, encouraging community involvement, prioritizing sustainability, preserving the campus heritage, and ensuring the harmonious integration of diverse campus communities.

# 8.1 Rezoning Daniel Drive and Vanier Boulevard

**WHEREAS** the City of Bathurst proposes to amend By-Law No. 2006-01 entitled "The City of Bathurst Municipal Plan By-Law" to allow the designation and use of the following lands as follows:

Change the land use designation of lots bearing civic numbers 1270 to 1296 Daniel Drive and 1330 Vanier Boulevard and bearing PIDs 20027793, 20027785, 20027769, 20027744, 20349247 and 20348231. For the purposes of the municipal plan, the land use designation is changed from "Residential" to "Integrated Development".

The purpose of this rezoning is to allow the development of a residential complex comprising several multi-unit rowhouses.

#### NOW THEREFORE BE IT RESOLVED THAT

- 1. Members of Council request in writing the written views of the Planning Advisory Committee on the proposed amendments,
- 2. The public presentation of the proposed amendment to the Municipal Plan take place on March 3, 2025, at 6:30 p.m. in the Council Chambers,
- 3. The City Clerk, acting on behalf of the Council, see that the public notice prescribed in section 25 of the *Community Planning Act* is posted on the municipality's website to announce the Council's intention, the day and place of the public presentation, and
- 4. The opportunity to make objections to the members of Council regarding the proposed by-law within thirty (30) days of the date of the public presentation by forwarding them to the City Clerk at City Hall.

# 10.3 Report from the Mayor

Mill Site Update: Met with Deputy Premier Legacy and Environmental Minister Lepage to discuss ongoing work at the Mill site. Additional work will occur this summer, and updates will be shared as available.

**Governance Reform:** Had a productive discussion with Minister of Local Government, Minister Kennedy, on governance reform, joined by the CAO and attending councillors.

# **Housing Announcements:**

• **Belle Baie Housing Funding:** On February 10<sup>th</sup>, attended a housing announcement in Belle Baie with Minister Hickey and MP Serge Cormier. Belle Baie received \$4.3 million for new housing units.

- **Bathurst Housing Progress:** Bathurst qualified for \$3 million under the Housing Accelerator Program, with a goal of 160 new units over three years. Over 100 new units are expected soon, with a 75% funding goal already reached. Development is expected to exceed the original goal.
- **Developer Recognition:** Habitat Soleil (44 units on Valley Lourde) and Mr. Drysdale (18 units on King Avenue) were recognized for their contributions to housing, including affordable units.

**Homelessness Initiative:** \$5.7 million has been allocated to address homelessness in Bathurst. Further discussions with Minister Hickey will follow.

**Public Works Appreciation:** Extended thanks to the Public Works team and city staff for their efforts in repairing the water break in South Bathurst during challenging weather. Also, gratitude was expressed for the citizens' patience and support shown on social media.

**Académie Assomption:** A request has been sent to Minister Johnson to arrange a meeting to discuss postponing the school's closure and develop a plan to keep it open.
